DURING THE COURSE OF ITS WORK, WHICH TOOK PLACE FROM JUNE 27 TO OCTOBER 15, 2018, AND INVOLVED A THREEFOLD APPROACH COMPRISED OF CONSULTATION, RESEARCH AND CLOSED-DOOR PROCEEDINGS, THE VILLE DE MONTRÉAL'S ADVISORY COMMITTEE ON THE ECONOMIC DEVELOPMENT OF THE TERRITORY ESTABLISHED THIRTEEN RECOMMENDATIONS, DIVIDED INTO FOUR SECTIONS.

SECTION 1

STRUCTURING PROJECTS AND THE DEVELOPMENT AREAS TO PRIORITIZE

Recommendation 1

Interorganizational coordination for structuring projects

The Committee recommends that the Ville de Montréal enhance and complement its economic development strategy with an interorganizational coordination initiative at the highest levels of decision making.

Recommendation 2

Effective support for different sectors

The Committee recommends that the Ville de Montréal adapt its support system to enable flexibility given changing needs based on sector dynamics.

Recommendation 3

Basic urban functions in neighbourhoods that need strengthening

The Committee recommends that the Ville de Montréal adopt an approach to economic development in targeted districts where underutilized labour is available, by concentrating efforts on basic urban functions of security, mobility and the presence of basic local infrastructure and services.

Recommendation 4

Public transit to employment centres

The Committee recommends that the Ville de Montréal place greater priority on planning, implementing and improving public transit in areas that receive large volumes of workers.

Recommendation 5

Profitability of residential projects

The Committee recommends that the Ville de Montréal work with real estate developers and economic players to identify solutions for social housing, affordable housing and family housing, while safeguarding the profitability of projects.

Recommendation 6

Vision of Montréal East

The Committee recommends that the Ville de Montréal work with the community and in close cooperation with the Government of Québec to establish a well-defined vision of the type of development desired for the central part of the large territory in the eastern portion of the Island of Montréal.

SECTION 2

ACCELERATE REAL ESTATE INVESTMENT AND THE CITY'S ECONOMIC DEVELOPMENT

Recommendation 7

Paramunicipal corporations to reinforce the development of hubs

The Committee recommends that the Ville de Montréal put in place one or more paramunicipal corporations to act as conduits for specialized real estate and economic development in areas with strategic assets.

Recommendation 8

TOD zones

The Committee recommends that the Ville de Montréal review land zoning in key sectors to create mixed zoning that reflects the concept of transit-oriented development.

Recommendation 9

Accelerated procedure for strategic projects

The Committee recommends that starting in 2019 the Ville de Montréal put in place an accelerated, transparent procedure to approve and support a limited number of major, strategic development projects.

SECTION 3

SPEAKING WITH A STRONG, UNIFIED VOICE IN THE INTERESTS OF THE CITY

Recommendation 10

Economic brand image

The Committee recommends developing, at the initiative of the Mayor of Montréal and the President of the CMM, a brand image for Greater Montréal that includes strong economic positioning, and having lead generation and promotion organization Montréal International handle the international deployment.

Recommendation 11

Positioning of hubs

The Committee recommends that the Ville de Montréal guide and support local positioning that emerges from the city's neighbourhoods and employment hubs, connected to the overall positioning resulting from Recommendation 10.

Recommendation 12

Distinctive elements for the city's image

The Committee recommends that the Ville de Montréal support reflection on the city's four distinctive elements – talent, quality of life, culture and sustainable mobility – to support the development of economic positioning for the city.
